**IT IS ORDERED THAT:**

- 1 The Application shall be dealt with administratively without the need for a hearing.

Walker of PwC Corporate Finance & Recovery (Cayman) Limited, PO Box 258, 18 Forum Lane, Camana Bay, Grand Cayman KY1-1104, Cayman Islands, is hereby released from the performance of any further duties as an official liquidator of the Company, without the need for any report and accounts to be prepared.

- 4.3 advertising this Order in the Gazette.
